LOCATION

The village of Marybank sits in an idyllic, semi-rural location within Ross-Shire in the Scottish Highlands. Local amenities are available at nearby Contin, 2 miles away, and Muir of Ord, some 4 miles distant. Dingwall is 6 miles away and the Highland capital Inverness is 17 miles away. Inverness provides a range of retail parks and supermarkets as well as many cultural and medical facilities. Inverness International Airport, with its growing selection of daily flights connecting the north of Scotland with Europe and beyond, is 25 miles away. The local countryside offers many opportunities for recreational activities including cycling, hill walking, canoeing and shooting. Stalking and fishing are readily available on local estates.

DESCRIPTION

This is a rare opportunity to design and build the home of your dreams with stunning, panoramic views across the breath-taking Conon Valley to Ben Wyvis and beyond. This small, boutique development of only six building sites offers a range of plot sizes from 740m2 to 1100m2, all of which will enjoy undisturbed views across the Conon Valley. As part of the development the seller will upgrade the existing entrance along with the internal access roads that will service each building plot.

PLANNING

Full Planning Consent has been granted for the six building plots. It is understood the permission is for 1 1/2 story, 3 or 4 bedroom homes. These building plots offer the purchasers the unique opportunity to construct a property to their own design and specification, given the necessary planning consents. A full design, planning and build service is available to interested parties if required.

SELF BUILDS

SERVICES

Each building plot will be fully serviced with Electricity, Mains Water and Telecom at the seller's expense. Drainage will be in the form of a private pumping station, which will also be provided by the seller. Each plot will be supplied with a connection to the drainage system within the boundaries of each building plot.

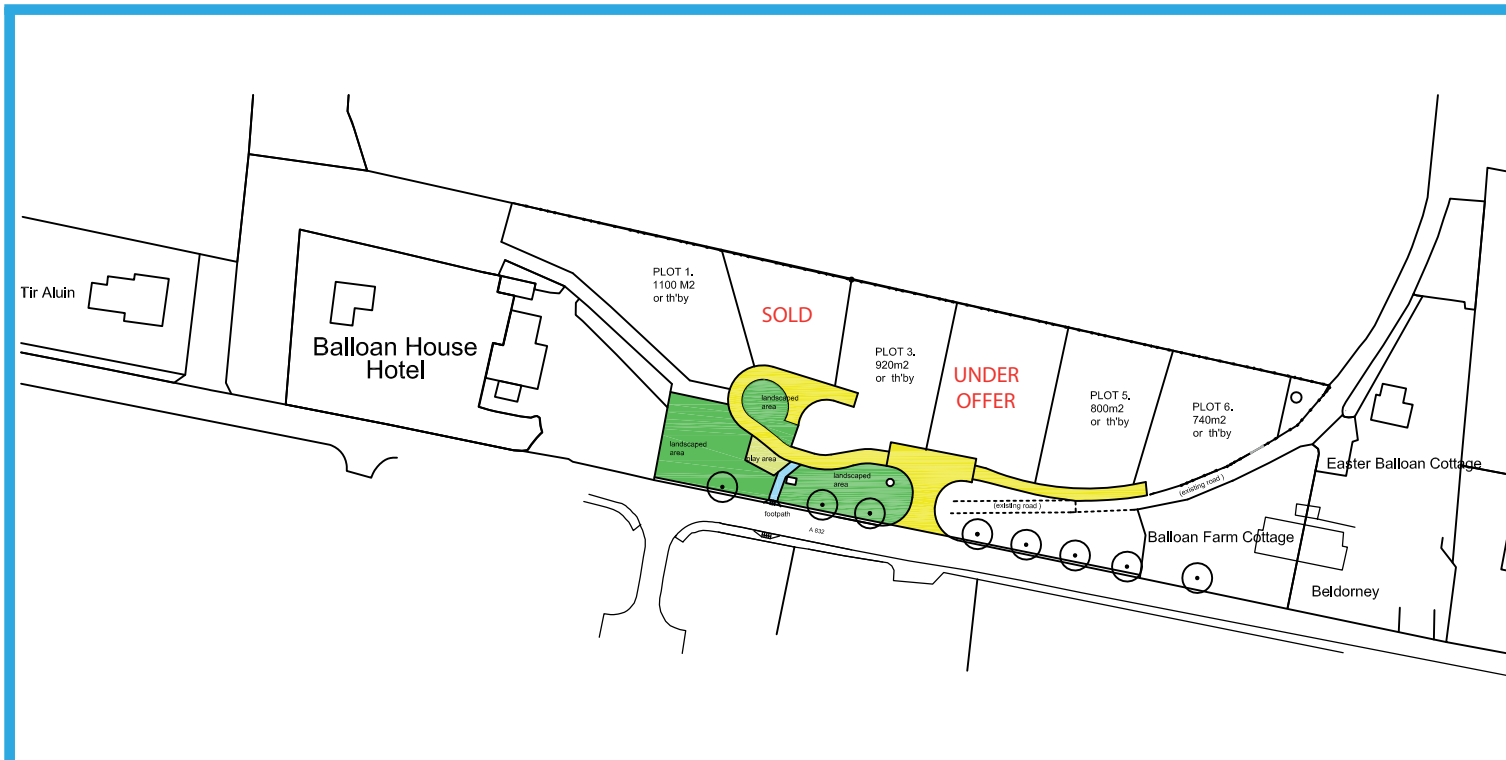
